Day by Day Itinerary

Wednesday, October 2 – LOUISVILLE / EN ROUTE

This afternoon we depart Louisville to begin the overnight transatlantic journey to Edinburgh, Scotland! (I)

Thursday, October 3 EDINBURGH / BRIDGE OF ORCHY

Shortly after the sun rises on the Scottish coast, we will arrive in Edinburgh and meet our Blue Badge Tour Guide, Jonathan Trew, who will introduce us to Bonnie Scotland. Leaving the airport, we'll travel to the village of Culross where we'll enjoy lunch at the cozy Red Lion Inn. Then we'll step into the past on a guided tour of Culross' cobbled streets. The most complete example of a burgh in the 17th and 18th centuries, Culross is acknowledged as one of the most picturesque villages in Scotland and is often used in the TV series, "Outlander." We'll discover the charming ochre-colored Culross Palace and its reconstructed stunning period garden, getting a sense of what it would have been like to live in Culross Palace in its prime. Leaving Culross, we'll stop to see The Kelpies, the largest equine sculpture in the world. A kelpie is a shape-changing aquatic spirit of Scottish legend, said to haunt rivers and streams, usually in the shape of a horse. Afterward, we'll continue across the Scottish countryside to the Bridge of Orchy, the gateway to Glencoe, perhaps Scotland's most famous and scenic glen, and arguably its most historic. (I,L,D)

Friday, October 4 – BRIDGE OF ORCHY

After breakfast, we'll drive out for a photo stop at Kilchurn Castle. Built in the mid-1400s, the castle was a fortress, a comfortable residence and later a garrison stronghold, and contains the oldest surviving barracks on the British mainland. Then we'll continue on towards St. Conan's Kirk, a favorite of visitors due to its magical lochside setting. Afterward, we'll enjoy lunch at the world renowned Scottish fish restaurant, Ee-Usk. With lobsters and crabs caught from the rocky coast of Luing, scallops from Mull and langoustines, mussels, and oysters from the cold clear waters of Loch Linnhe, all the shellfish is 100% locally sourced. After lunch we'll visit Oban Distillery, one of the smallest whisky makers in Scotland, for a tour and tasting. **(B,L)**

Saturday, October 5 BRIDGE OF ORCHY / FORT WILLIAM

This morning we depart Bridge of Orchy and travel to the charming Glencoe Visitor Centre. This amazing ecofriendly center, nestled in a woodland glade, is an essential starting point for our todays adventure and we'll get a taste of the stories that make Glencoe National Nature Reserve so special. We'll enjoy a stroll of Glencoe Lochan with its stunning views of the Pap of Glencoe, and then we'll drive around the much larger Loch Leven, taking in striking panoramas of the loch, including views over the burial island, Eilean Munde. We'll also stop in Kinlochleven, and perhaps check out the Grey Mares Tail waterfall – just a short walk from the village. We'll end our drive at The Laroch Restaurant and Bar, where we'll enjoy lunch featuring locally sourced ingredients, before making our way to Fort William. **(B,L,D)**

Sunday, October 6 – FORT WILLIAM (Isle of Skye)

A leisurely day on tour will take us across the Skye Bridge to the Isle of Skye. The largest of the Inner Hebrides, the Isle of Skye is saturated with 4,000 years of myth and history. We'll learn about long ago feuds between rival clans, Jacobite intrigue, and the devastation of the crofting communities during the Highland Clearances. journey up the east coast, marked by spectacular rock scenery as we set out to discover the most northerly of Skye's peninsulas, Trotternish. Extending north from Portree to its eventual end at Rubha Hunish, it contains some of the most striking landscapes in Scotland. We'll see The Storr, the dramatic summit rising 2,350 feet above the east-facing cliffs that run down the center of the peninsula, and the Old Man of Storr, a 165-foot tall rock. Best of all is Kilt Rock, 200-foot high cliffs marked in an almost tartan-like pattern by the rock strata, and with a waterfall tumbling sheer to the pebbled shore below. We'll also be sure to allow time along the way for plenty of photos, lunch at Skeabost House, and a view of the most photographed castle in Scotland, the famous stronghold of Eilean Donan Castle. (B,L,D)

Monday, October 7 – FORT WILLIAM / INVERNESS

This morning we depart Fort William and make our way north to Urquhart Castle, offering a taste of the Highlands at their most dramatic. Once one of Scotland's largest castles, Urquhart saw great conflict during its 500 years as a medieval fortress. Control of the castle passed back and forth between the Scots and English during the Wars of Independence. The power struggles continued, as the Lords of the Isles regularly raided both the castle and glen up until the 1500s. Next, we'll enjoy lunch at the elegant Culloden House before a visit to Culloden Moor, the powerfully emotive and atmospheric battlefield where in 1746 the final Jacobite Rising came to a brutal head in one of the most harrowing battles in British history. We'll explore the richly researched Culloden Visitor Centre, featuring artifacts and interactive displays that reveal the background on both sides of the conflict. Afterward, we'll travel to Inverness, the cultural capital of the Scottish Highlands. (B,L,D)

Tuesday, October 8 – INVERNESS

Today we will travel to Elgin, one of Scotland's world-famous whisky regions known for its local distilleries and breathtaking scenery. Here, we'll visit Elgin Cathedral, which, even as a ruin shines as one of Scotland's most ambitious and beautiful medieval buildings. Then we'll explore the famous whisky heritage of the area at the Speyside Cooperage, which has produced the finest casks from the best American Oak since 1947. We'll also enjoy an Afternoon Tea at Dowans Hotel, where their in-house baker serves up a delicious array of treats, both savory and sweet, freshly prepared every day. **(B,L)**

Wednesday, October 9 – INVERNESS

The morning is at leisure to explore on our own or relax and enjoy the amenities of our hotel. After time for lunch, we'll make our way to Dochgarroch Lock to embark on an afternoon cruise. We'll experience a breathtaking journey that takes us along Thomas Telford's famous Caledonian Canal and, of course, across the legendary waters of Loch Ness, one of the best ways to enjoy the Highland's stunning scenery while learning about the colorful history of the loch, including the crash site of a World War II Wellington Bomber, along with some stories about the world's shyest monster. (B)

Thursday, October 10 – INVERNESS / ABERDEEN

This morning we depart Inverness and travel through stunning Cairngorms National Park to the Highland Folk Museum to learn how the Highland people lived and worked from the 1700s up until the 1950s. Britain's first open-air museum, the site features over 30 historical buildings set amidst some of the most beautiful scenery in the world. Following our visit, we'll make our way to the Kildrummy Inn for a traditional lunch in the heart of rural Aberdeenshire. Afterward, we'll continue our journey to the port city of Aberdeen. **(B,L,D)**

Friday, October 11 – ABERDEEN

Today we travel to Aberdeenshire to visit the magnificent fortress that is Fyvie Castle, a sterling example of Scottish Baronial architecture. As we'll soon find out, ghosts, legends and folklore are all woven into the tapestry of Fyvie's 800-year-old history. Next, we'll stop at Redgarth Inn for lunch before a short drive down the road brings us to Aberdeenshire Sheepdogs, where Gary and Michelle Bruce will share their experiences working, training and trialling with their Border Collies, and share stories about life on a Scottish sheep farm. We'll be invited to meet the dogs and even have an opportunity to try working the dogs! Depending upon seasonal weather, we may also have a chance to watch a sheep shearing demonstration or bottle feed orphan lambs. (B,L)

Saturday, October 12 – ABERDEEN / EDINBURGH

This morning we depart Aberdeen and head south, stopping along the way in Dundee for a visit at Verdant Works, a world class attraction which tells the story of Dundee's industrial textile heritage in the beautifully refurbished Mill building. We'll hear the tales of the mill workers, see how they lived and worked, and explore this amazing building, where we'll see (and hear) the machines at work, and step back to a time when the Mills were the heart of Dundee. After time for lunch at the café, we'll travel south to Edinburgh, where on arrival we'll have an introduction to Scotland's capital city. **(B)**

Sunday, October 13 - EDINBURGH

Our day begins along the Royal Mile to view the Palace of Holyroodhouse, the official Scottish residence of His Majesty the King, before stopping at Edinburgh Castle perched high above the city on volcanic rock. Our visit will reveal an assemblage of buildings dating from the 12th to the 20th century, reflecting its changing role as fortress, royal palace, military garrison, and state prison. Then we'll experience 400 years of history with a visit to The Real Mary King's Close, hidden beneath the lively streets of Edinburgh's busy thoroughfare, the Royal Mile. Edinburgh's only preserved 17th century street, the Close and its warren of shops, homes, and passageways offer a truly unique experience. With our guide, we'll wander through the now underground labyrinth that was once a busy Edinburgh laneway to discover the stories of the people who lived, worked, and died here.

Following our tour, the remainder of the day is at leisure. Central Edinburgh is compact, so walking is an excellent way to explore the city. Neatly divided in half by Princes Street, the principal shopping area is also home to art galleries, the landmark Balmoral Hotel clock tower, and the city's main rail station. To the south lies the Old

Town, site of the ancient city which grew along the route of the Royal Mile comprised of Castlehill, Lawnmarket, High Street, and Canongate. **(B)**

Monday, October 14 - EDINBURGH

Today we'll travel south of Edinburgh to visit stunning Rosslyn Chapel. Founded in 1446 as a family chapel, the building has enjoyed a rich, and sometimes turbulent, history. The beauty of its setting, in rural Midlothian, and the mysterious symbolism of its ornate stonework have inspired, attracted and intrigued writers, artists and visitors ever since. Rosslyn Chapel came to worldwide prominence through The Da Vinci Code, a novel written by Dan Brown, published in 2003. This evening we'll be treated to a fabulous farewell dinner featuring elegant and delicious local specialties. **(B,D)**

Tuesday, October 15 – EDINBURGH / LOUISVILLE

As all good things must come to an end, so too does our *Scottish Adventure*. This morning we travel to Edinburgh Airport in preparation for the return journey home. No better time to reflect on memories of our vacation to last a lifetime and new friendships made along the way! **(B,I)**
